June 27, 2016

1. Call to order.

The 430th meeting of the Santa Monica Mountains Conservancy and Santa Monica Mountains Conservancy Advisory Committee was called to order by Acting Chairperson Jerome C. Daniel, at 7:30 p.m. on June 27, 2016 at the Agoura Hills Event and Recreation Center, Agoura Hills, California.
