March 27, 2017

1. Call to order.

The 437th meeting of the Santa Monica Mountains Conservancy and Santa Monica Mountains Conservancy Advisory Committee was called to order by Chairperson Irma Muñoz at 7:30 p.m. on March 27, 2017 at the Arroyo Vista Recreation Center, Sycamore Room, in Moorpark, California.

2. Administration of Oath of Office to new members.

The Executive Director administered the Oath of Office to Patt Healy, representing the City of Malibu, on the Advisory Committee.

3. Roll Call of Conservancy.
